IN THE MATTER OF CONSIDERATION OF FIT/CVET FUNDS DISTRIBUTION

Patti Foxx, Auditor, explained the FIT/CVET distribution had changed under HEA 1392 act. The SBOA recommends putting the funds into County General. This was the recommendation by the County Auditor.

A motion to distribute FIT/CVET distribution into County General was made by Bryan Allender and second by Paul Sinderson. Motion carried 3-0.

IN THE MATTER OF ACTION ON THE REQUEST FOR APPEAL BY CHRISTOPHER A STYLEBURG

Marty read the decision of the Board of Commissioners of Clay County, Indiana the following:

DECISION OF THE BOARD OF COMMISSIONERS OF CLAY, COUNTY, INDIANA

Christopher A. Styleburg d/b/a Jack's Fine Foods delivered a letter which was referred to as a "Styleburg Appeal" from Tina Styleburg, by email, to the Commissioners on November 4, 2025. Such matter pertains to the alleged closing of Jack's Fine Foods by the Clay County Health Department on October 25, 2025 for failure to have a ServeSafe Manager Certificate.

Ind. Code 16-20-5.5-2(b) provides "In order to make an appeal

under this chapter, the recipient of the enforcement action must file the appeal with the legislative body not later than seven (7) days from the issuance of the enforcement action.”

Under the provisions of Ind. Code 16-20-5.5-3(a) the Board of Commissioners of Clay County declines to hear such Request for Appeal.
