**INTERLOCAL AGREEMENT BETWEEN**  
**THE CLAY COUNTY BOARD OF COMMISSIONERS**  
**AND THE TOWN OF CENTER POINT, INDIANA**

This agreement is made and entered into this \_\_\_ day of August, 2014, by and between the Clay County Board of Commissioners, located at the Courthouse Auditor 609 E. National Brazil, Indiana, 47834, with the approval of the Clay County Council, and the Town of Center Point, Indiana Clerk/Treasurer P.O. Box 177 Center Point, Indiana 47840.

Whereas, the Clay County Board of Commissioners and the Town of Center Point, Indiana desire to enter into this Interlocal Agreement pursuant to I.C. 36-1-7, for the purpose of the Clay County Highway Department providing chip & seal improvements to CR 200 North from Sugar Ridge Estates to CR 200 East through the corporate limits of the Town of Center Point, Indiana, which will be to the benefit of Center Point, Indiana and all Clay County citizens;

NOW, THEREFORE, in consideration of mutual promises and covenants contained herein, the Clay County Board of Commissioners and the Town of Center Point, Indiana hereby enter into the following Interlocal Agreement:

- I. Duration of the Agreement: This Agreement shall be for a one time chip & seal roadway improvement project to take place during the time period of approximately August - September 2014, when the County performs chip & seal improvements to other portions of CR 200 North in the vicinity of the Town of Center Point, Indiana.
- II. Purpose of Agreement: The purpose of this agreement is for chip & seal roadway improvements on CR 200 North, through the Town of Center Point, Indiana, to be consistent with improvements to such roadway outside the Corporate Limits of the Town of Center Point, Indiana. The Clay County Board of Commissioners, through the Clay County Highway Department is willing to assist as stated herein, which will be to the benefit of Center Point, Indiana and all Clay County citizens;

III. Services to be Provided and Cost Thereof: The Clay County Board of Commissioners, through the Clay County Highway Department, shall provide chip & seal roadway improvements on CR 200 North, through the Town of Center Point, Indiana from Sugar Ridge Estates to CR 200 East at the following cost to the Town of Center Point, Indiana:



Such sum shall be paid by the Town of Center Point, with payment by check payable to the Clay County Treasurer and be delivered to the Auditor of Clay County, Indiana, upon the services being performed.

- VI. Effective Date of Agreement: The parties acknowledge that the effective date of this Interlocal Agreement shall be pursuant to I.C. 36-1-7-10 which requires this Interlocal Agreement to be:
- a. approved by the fiscal body of each party;
  - b. recorded with the County Recorder;
  - c. filed with the executive of the municipality and the Auditor of the county; and
  - d. file with the Auditor of the State.
