INTERLOCAL AGREEMENT BETWEEN  
THE CLAY COUNTY BOARD OF COMMISSIONERS  
AND THE CITY OF BRAZIL, INDIANA

This agreement is made and entered into this 2 day of Sept, 2014, by and between the Clay County Board of Commissioners, located at the Courthouse Auditor 609 E. National Brazil, Indiana, 47834, with the approval of the Clay County Council, and the City of Brazil, Indiana Clerk 203 E. National Brazil, Indiana 47834.

Whereas, the Clay County Board of Commissioners and the City of Brazil, Indiana desire to enter into this Interlocal Agreement pursuant to I.C. 36-1-7, for the purpose of the Clay County Highway Department providing chip & seal improvements to Pinckley Street between State Road 59 to Murphy Ave., (approximately 5,100 feet) (hereinafter referred to as the "Project") which lies within both the City of Brazil and Clay County jurisdictions; and which will be to the benefit of the City of Brazil, Indiana and all Clay County citizens;

**NOW, THEREFORE**, in consideration of the mutual promises and covenants contained herein, the Clay County Board of Commissioners and the City of Brazil, Indiana hereby enter into the following Interlocal Agreement:

- I. Duration of the Agreement: This Agreement shall be for a one time chip & seal roadway improvement project to take place during the time period of approximately September or early October, 2014, when the County performs chip & seal improvements to other portions of Pinckley Street outside the corporate limits of the City of Brazil, Indiana.
- II. Purpose of Agreement: The purpose of this agreement is for chip & seal roadway improvements on Pinckley Street, through the City of Brazil, Indiana, from State Road 59 to the corporate limits, and on to Murphy Ave. to be consistent with improvements to such roadway outside the Corporate Limits of the City of Brazil, Indiana on Pinckley Street. Department is willing to assist as stated herein, which will be to the benefit of the City of Brazil, Indiana and all Clay County citizens.


III. Services to be Provided and Cost Thereof: The Clay County Board of Commissioners, through the Clay County Highway Department, shall provide chip & seal roadway improvements on Pinckley Street, as stated above at the cost to the City of Brazil, Indiana for labor and materials of \$10,000.00. Additionally, the City of Brazil, Indiana shall provide traffic control services as may be needed by the Clay County Highway Department which is intended to be for one-half day or less.





- d. file with the Auditor of the State.


