JOINT RESOLUTION ESTABLISHING RESPONSIBILITY OF ROADS
IN THE CLAY CITY AREA

WHEREAS, there has been uncertainty in the responsibility for various streets and roads in the Clay City area between the Board of Commissioners of Clay County, Indiana and the Town of Clay City;

NOW THEREFORE, the parties agree to the following Summary of Responsibility for the specified Clay City and Clay County Streets and Roads:

Streets belonging to Clay City:

1st Street from SR 59 and west to Nye Street.
1st Street from SR 59 and east to Lankford Street.
Nye Street from Water Tank (at park entrance) and south to SR 59.
Lankford Street from Old Road SR 59 (1st Street) and south to 14th St.
7th Street (CR 750 S) from Cook Street west to Outline Street.
Cherry Street from 7th Street to 8th Street.
Outline Street from 7th Street to the north, and east to Forrest St.
Main Street from SR 157 and south to 14th Street.

Streets/Roads belonging to Clay County:

Old SR 59 from intersection of 1st and Lankford Streets to the north.
CR 700 S. (1st Street) from intersection of 1st and Lankford Streets to the east.
CR 700 S. (1st Street) from Nye Street to the west.
Nye Street from Water Tank (at park entrance) and north to the CR 700 S. (1st Street).
CR 750 S. (7th Street) from Cook Street and to the east.
Cook Street from 7th Street and to the north to dead-end.
Fair Street from SR 157 to the south and around to 14th Street.
14th Street (CR 800 S.) from SR 157 west to SR 59.
Meridian Road (Lankford Street) from 14th Street (CR 800 S.) and to the south.

Clay County:

The County is responsible for the repair and maintenance of all street bridges and culverts under the roadways, within the Clay City limits, (covered under the County Bridge Fund).

Harrison Township Trustee:

The Trustee is responsible for the repair and maintenance of all roads

in Goshorn Park (Clay City Park).

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAY COUNTY, INDIANA, that the above stated responsibilities for the above stated streets and roadways shall be in effect when signed and approved by the Board of Commissioners of Clay County, Indiana and by the Town Council of Clay City, Indiana.
